- Busier with one time events, but looking for more longer term regular clients
  - Alzheimer's group
  - Possible Art group

#### Renovations

- Elevator Project
  - Problem no Accessible door opener on 2<sup>nd</sup> floor for Elevator doors
- Flooring replace 2<sup>nd</sup> floor main room flooring
- Post Elevator Project
  - Renter feedback suggests that lockable onsite storage is a priority over additional Accessibility or general upgrades
    - Currently investigating



#### By-Laws - Background

- By-Laws last updated in 1989
- KBCA had very different responsibilities and raison d'etre then compared to now
- Kanata was incorporated into City of Ottawa in 2001
- By-Laws did not reflect new reality of how the KBCA fit into the community

### By-Laws – Coming Gov't Req'ts

- Ontario's Not-for-Profit Corporations Act, 2010 (ONCA) encourages use of their By-Laws template
- This was used for the drafting of the new KBCA By-Laws

## By-Laws – Highlights

- All references to owning and managing property have been removed as KBCA gave up these properties under amalgamation
- All references to managing the community appropriate to pre-amalgamation era have been removed
- Vision, Mission and Purpose of the KBCA as developed since last AGM were added (Section 1.6)
- Requirement to have Directors from each specific cluster of home was relaxed (Section 2.1)

#### By-Laws – Highlights (cont'd)

- Landlords as Corporate Members have been limited to one vote only vice one per property (Section 1.1 h(c) and 9.7 b)
- Ability of President/Chair to cast an additional vote to break a tie has been removed (Section 3.2 3.6 and 9.6e)
- Reference to a membership fee has been retained although the fee is zero at the moment.
- Use of electronic means to vote at Director's meetings has been expanded to reflect current technology

#### **Beaverbrook Street Signs & Lighting**



- 70 originally installed
- 59 remain
- Most could last many years with repair/replace

- KBCA developing & investigating options
  - Replacement
  - Refurbish lit box only
- KBCA discussing options for Funding with City (grants, budget)
- Likely we will need to fundraise



#### Immigration/Origin



- Problem
  - Forest canopy is under pressure (worsened by EAB)
  - Incomplete data about forest resource
  - Limited City resources for trees on private land
- Solution
  - Adopt the proven Neighbourwoods methodology
  - Tree assessment course Jun 16-18 (Dr. Andy Kenney)
  - Implement tree inventory using volunteers
  - Foster citizen stewardship
- Other
  - Link with City of Ottawa UFMP
  - Collaborate with like-minded groups
  - Implement a sustainable process

- Train the trainers







#### Forestry

- City of Ottawa Urban Forest Management Plan (UFMP) – final version to Council in May
- City Forestry group manages trees on city property not those on private land
- Butternut Recovery Program (Ottawa Stewardship Council & RVCA)
  - Endangered species
  - Part of Ash replacement program
  - KBCA Planting & custodian role Scouts/Ventures

#### **Ottawa Park Summit**

- Held April 22 (Earth Day)
- Hosted by Ecology Ottawa
- Highlights:
  - 'When Communities get Involved Parks Get Better'
  - Many volunteer organizations participated various initiatives in Ottawa Parks
  - How the City is organized around parks
  - Park People Toronto company bringing international solutions to Canada (urban parks)
  - Great networking opportunity.
